Andy Hansen was Plant Manager at John Deere Ottumwa Works from 2010-2013. While in Ottumwa, Andy provided leadership and encouraged others to step into leadership roles. He demonstrated his leadership through volunteerism and being a board member to several community organizations including the Legacy Foundation. The Legacy Foundation wanted to honor Andy's dedication to the betterment of the Ottumwa community by creating the Andy Hansen Legacy Scholarship.
